## **Beaverhead Watershed Grants**

- Zach has been working on the WSA stuff, wrapping up planning for the grasshopper project, started measuring flows on the Red Rock again, submitted a proposal for funding to update our drought plan, and has been doing a lot of work on the Beaverhead BOR flow educational brochure. He got a bunch of contracts set up with BLM funds to monitor the East Creek de-hummocking project with a drone, get the Stone Creek nutrient wetland project ready for a grant proposal, do a wetland delineation on Moose Creek for a project, and a university student is doing a research project on measuring approximate board-feet using a drone. He's also meeting with a consultant to see if they can help with a community development plan for the YMCA area, if it's not too late with the empty lots there. Also, he's working on the Red Rock WRP again since DEQ finally came out with TMDL data.
