## **Beaverhead Watershed Grants**

Zach has been working on the Landscape Conservation Design project, and the Wilderness Study Area group. He did the Elkhorn snow survey course for NRCS and is working with the High Divide Collaborative on their spring workshop, which he will be attending next week in Salmon, ID. He's been talking with the engineer who helped with the Grasshopper mine tailing project to plan for this summer when those grant funds show up. He also helped the Big Hole Watershed Committee submit another grant application for the Elkhorn Mine & Mill cleanup projects they've been working on. He met with BLM, and we're going to submit a proposal for another cooperative agreement.

Motion to approve Watershed finances for April by Billiette 2<sup>nd</sup> by Tom, motion carried.

### **Administrator Report**

- The watercraft inspections station has found 3 mussel boats. Cliff Billings has left the station and Dylan Vanderschaaf replaced him. WIS is running smoothly and the hot water wash unit is working but waiting on one side to be replaced. It did not work from the beginning but is under warranty.
- The ARPA grant we have is looking for another project that has a direct nonpoint source pollution reduction. Matt mentioned the Ryan Cypher place and possibly narrowing the creek, Jess will check with Autumn Coleman and see if the money could be used there. The project is not TMDL listed.

#### **Old Business**

- MACO insurance (liability, auto, omissions and errors)- Payne West insurance was not able to create a plan for districts, Mountain View has not been overly helpful in finding a policy, Western Horizon out of Bozeman could not make a plan for districts. Rocky Mountain Insurance is now working on creating an insurance plan (other districts quotes are around \$4,000-5,000 depending on revenue).
- Increasing Employee Health Stipend
- *Motion to increase the employee health stipend to \$400 by Billiette, 2<sup>nd</sup> Rich, Motion Carried* (\$390 permissive health stipend, \$10 district)

- Admin Grant Application. If the funding bill passes, we may get the full ask if not we will get roughly \$10,000 depending on what funding DNRC receives,
- Motion to ask for \$45,000 from the Admin Grant to hire another employee by Harris, 2<sup>nd</sup> by Rich, Motion Carried.
