- I'm working with the County Attorney on the Elkhorn/Big Hole/DNRC stuff. I'm hoping to meet with him this week. We can't send DNRC the final stuff until he's reviewed everything. We should be ready for construction on the Grasshopper project next month. Rowe will be able to start hauling rock to Bannack this month, but we have to wait till willows are dormant to start construction. Wednesday night BCC held our first public meeting since having a draft agreement. Maybe Byron can update the group if he was able to attend? I attached our friend Kerry White's (Citizens for "Balanced" Use) email to their supporters. As usual, making a business out of lies and misrepresentation. If he's not careful, he'll discredit himself and we won't need to do it for him. This won't be the last attack from them, and we can expect it from more extreme wilderness advocacy groups too.
