Beaverhead – Matt Jaeger

- BCD 2536 Double C Ranch Holdings, Winslow Creek, Pond Clean Out
Scott Davis came and explained the project, FWP is in favor because they are trying to create a pure strain of west slope cutthroat that does not have rainbow trout DNA. Tom suggested to move the second screen back 4-6 inches so that the waterflow will clean it out. Scott appreciated the suggestion.

- BCD 2537 Double C Ranch Holdings, Winslow Creek, divert water around pond to avoid sedimentation
